



BERGMENN EHF. 2021 BOOKING CONDITIONS

MANAGEMENT / ORGANIZER

Bergmenn ehf. is the organizer of the ski packages described on our websites. Any travel agent or individual representing Bergmenn ehf. is acting only as an agent authorized for encashment.

Note: The term “ski touring” shall include splitboarding, telemark skiing and heli accessed ski touring.

2021 UPDATED BOOKING POLICY

In light of the Covid-19 pandemic we have implemented some changes in our booking and cancellation policy to ensure that you feel comfortable booking.*

REGISTRATION POLICIES AND CONDITIONS

By submitting a registration form online and paying a deposit, the client has entered into an agreement with Bergmenn ehf. The completed registration form along with the terms and conditions, ski packages or quote and the rates and dates constitute a legally binding agreement between Bergmenn ehf. and the guest.

PRICE, DEPOSITS AND PAYMENTS

Each guest should familiarize themselves with these terms and conditions and our website. This will ensure that you pick the best package for your needs and that you have a full understanding of what a package entails.

Price

The stated price for the Service includes all fees (fees and/or taxes the Icelandic authorities may impose on the Service covered by the agreement).

Furthermore, the price shall include any additions stated in the Service description on the Bergmenn website.

Some down day activities come as an extra cost and guests will be made aware of this prior to participating in any such activities. All non-touring travelers shall pay all extra costs not included in the description for the Service.

The price for any cancellation protection and/or travel insurance comes in addition to the Service price and is not covered by the provisions of this paragraph. The same applies to any connecting journey or land arrangements that are not part of the Service.

Deposits

Please contact us by email to reserve a space on one of our ski packages.

A deposit and a completed registration form are required within 1 week of the reservation date to confirm your reservation.



The deposit is 25% of your total package price, or as requested by your travel agent. The exact amount will be calculated and sent back to the guest in the reply to his initial booking request.

The following deposit conditions apply to 2021 booking:

1. Deposits made before 1.December 2020 are fully refundable
2. After 1.December 2020 all deposits are non-refundable.

Balance Payments:

Final payment is required 30 days prior to commencement of your package or as required by your travel agent. If a booking is made less than 30 days prior to the start of the ski package full payment is due to confirm and secure the space.

CANCELLATIONS

All ski packages start and finish on the specified dates and have been offered as a complete package. There are no refunds, partial or full for any of the following reasons.

- Late arrival or early departure for any reason
- Sickness or injury
- Lack of skier ability or fitness

Cancellations must be made by email. If you are unable to attend your ski package after the final payment date then the ski package is transferable to another person. If Bergmenn ehf. is able to find a replacement for your space then your package payment can be deferred to a ski package in the next season. Please note that rebooking is subject to availability,

Cancellation more than 30 days prior to the start date of the package will result in loss of the deposit. If cancellation is received 30 days or less to the start of the confirmed package then the entire trip price is owed and non refundable.

Bergmenn ehf. reserves the right to cancel any touring package at any time (non-COVID related). Should this occur a full refund of payments, including deposit, will be given.

Bergmenn ehf. is not responsible for any costs outside of your touring package (e.g. pre/post program travel expenses including flights and accommodation)



***COVID-19 TERMS**

Should you have to cancel your 2021 program to comply with COVID related border, travel or quarantine restrictions after your balance payment has been made, there are two options:

1. Move your entire payment to the 2022 season and maintain 2021 pricing for your new booking.*
2. Move your deposit to the 2022 (or 2023) season and receive a refund of your balance payment. Your 2022 (or 2023) balance is then due 30 days prior to your new trip start date and subject to our annual price increases.
3. Full Refund

*Rebooking is subject to availability.

The same options apply if Bergmenn has to cancel the 2021 season to comply with COVID related border, travel or operational restrictions (for example but not limited to: physical distancing, quarantine advisory).

Cancellations due to COVID-19 must meet one of the following:

1. A border closure or advisory against non-essential travel that prevents you from leaving your home country or coming into Iceland.
2. A government imposed mandatory quarantine period that makes travel not possible.
3. If you have tested positive for COVID-19 (or come into close contact with someone who tested positive) within two weeks of your trip start date.

*Any cancellation request outside of the COVID-19 terms including injury and sickness will not be considered as part of our 2021 COVID-19 exclusion and falls under our normal cancellation policy (see above "CANCELLATIONS". We require guests to purchase trip cancellation / interruption insurance to be covered for these risks.

REFUNDS

No refunds are given in whole or in part for unused days within the package due to a late arrival or early departure. Should the entire group not be able to tour for a day due to conditions no refund will be given.

LIABILITY

Each guest will be required to sign a RELEASE FROM LIABILITY, WAIVER OF CLAIMS ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT.

By signing this agreement/waiver you are giving up certain legal rights. This agreement/ waiver must be signed and witnessed before the guest is allowed to ski. Refusal to sign this waiver will result in cancellation of that guests ski package with no refund of any sort.

INSURANCE

Because of the costs involved in heli skiing Bergmenn ehf. require that each guest purchase trip or holiday cancellation insurance in addition to medical, personal and travel insurance. This insurance should cover emergency helicopter evacuation. Contact your local travel agent or insurance provider for details.
