**General Business Terms and Conditions 2009 - 2010**

**Management/Organizer:**

Bergmenn ehf. is the organizer of the packages described on our website. Any travel agent or individual representing Bergmenn ehf is acting only as an agent authorized for encashment.

**Note: All prices are in (Euro)**

**Registration Policies and Conditions:**

By submitting a registration form and paying a deposit the guest has entered into an agreement with Bergmenn ehf. The completed registration form along with the terms and conditions, packages or quote and the rates and dates constitute a legally binding agreement between Bergmenn ehf and the guest.

**Deposits, Registration and Payment:**

Each guest should familiarize themselves with these terms and conditions and our website. This will ensure that you pick the best package for your needs and that you have a full understanding of what your package entails.

**Contact us by email to reserve a space. A non-refundable deposit and a completed registration form are required within 1 week of the reservation date to confirm your reservation.**

**The deposit is 30% of total package price for regular departures. The exact amount will be calculated and sent back to the guest in the reply to his initial booking request.**

**For day trips the full amount 100% is due upon booking.**

**For multi day private guiding the deposit is 50% of total price.**

**To secure your space, final payment is required 90 days prior to commencement of your package. If booking less than 90 days prior to start of package full payment is due to confirm and secure the space.**

**Refunds:**

**Bergmenn ehf strongly suggest that each guest purchase trip or holiday cancellation insurance**

No refunds are given in whole or in part for unused days within the package due to late arrival or early departure.

**Cancellations:**

All packages start and finish on the specified dates and have been offered as a complete package. There are no refunds, partial or full for any of the following reasons.

- Late arrival or early departure for any reason
- Sickness or injury
- Lack of ability or fitness

Cancellations must be made by email. If you are unable to attend your package after the final payment date then the package is transferable to another person. If Bergmenn ehf is able to find a replacement for your space then your package payment can be deferred to a package in the next season.

Cancellation more than 90 days prior to the start date of package will result in loss of the **non-refundable** deposit. If cancellation is received 90 days or less, prior to start of confirmed package then entire trip price is owed and **non refundable**.

Bergmenn ehf reserve the right to cancel any package at anytime. Should this occur a full refund of payments including deposit will be given.

**Liability:**

Each guest will be required to sign a **RELEASE FROM LIABILITY, WAIVER OF CLAIMS ASSUMPTION OF RISKS AND INDEMNITY AGREEMENT**. By signing this agreement / waiver you are giving up certain legal rights. This agreement / waiver must be signed and witnessed before the guest is allowed to ski. Refusal to sign this waiver will result in cancellation of that guests package with no refund of any sort.

**Insurance:**

Bergmenn ehf strongly suggest that each guest purchase trip or holiday cancellation insurance in addition to medical, personal and travel insurance. This insurance should cover emergency helicopter evacuation. Contact your local travel agent or insurance provider for details.
